Mission

The Mustang Fund, Inc. is a not-for-profit fundraising organization supporting Montgomery Elementary School's (MES) pursuit of excellence in education. Our focus is supporting curriculum enhancements for the school by enriching the learning environment in every classroom for every student. We rely upon individual contributions, corporate donations, and community fundraising events to achieve our mission. Through the Mustang Fund, parents, teachers, neighbors, businesses, administrators, and staff work together toward a common goal: **excellence in public education**.

Vision

The ultimate goal of the Mustang Fund will ensure that Montgomery continues to be a sought after public elementary school. Specifically, our vision is to ensure that the fund actively:

- Enhances the experience of every MES student
- Enriches faculty, programming, and equipment within the walls of MES
- Actively assists in preparing our student body for success in middle and high school
- Gives back to students, parents, faculty, local businesses, and private citizens as a vital part of our community
- Ultimately, assists in ensuring that our Montgomery community remains a sought-after community in the Atlanta area

Establishment

The Mustang Fund was established as an official entity on September 9, 2010 and achieved 501(c)(3) status on February 13, 2012.



2017-2018 Review

- The Mustang Fund's primary fundraising effort this school year was to fund the MES Ignite! initiative.
 The three MES Ignite! areas included:
 - Innovation Lab 1.0: A classroom was transformed into a flexible, aesthetically pleasing learning space modeled after the Georgia Department of Education's Center for Classroom Innovation. It features new furniture, technology equipment and learning tools that allow us to enhance students' 21st century skills and provide blended learning opportunities. Moreover, it supports learning opportunities geared towards having students investigate and respond to authentic and complex questions, problems and challenges.
 - Imagine Mustang Art: Enhancements were made to our art program that foster opportunities to blend our Art, STEM, and Technology curriculums.
 - o Maximize STEM: We support enhancements to our MES STEM curriculum.









- Through several fundraising efforts, we raised a total of \$64,597.06 in donations and other fundraising activities during the 2017-2018 academic year.
- The Mustang Fund's balance as of June 30, 2018 was \$304,653.85.



• The Mustang Fund remains committed to supporting Montgomery's STEM Certification efforts. We continue to fund opportunities for student learning, support faculty training efforts in STEM curriculum, and provide support for technology integration within classrooms and the STEM lab.

2017-2018 Board Actions and Results

Fundraising

- The foundation once again conducted an annual appeal to the MES community, generating \$25,183.28 through donations among family, friends, corporate matches, and other company donations.
- Through a concentrated effort on fundraising within our community, the Mustang Fund continued to build the business partner program and raised \$36,907.89 from local businesses.
- The foundation continued to build our partnership with Ed Voyles through the Chamblee Cluster Schools Car Raffle. The second annual raffle generated \$2,505.89 in additional funds, net of expenses.
- Contributors were acknowledged through personalized letters and listed on website/newsletters and are also featured in this annual report.

Expenses

- Teacher training and professional development continues to be an area of focus. \$15,250.00 was invested in our teachers which directly impacts our children every day. This included continuing to support certification of all MES teachers in the Orton-Gillingham Approach, an intensive, sequential phonics-based system that teaches the basics of word formation before whole meanings. The method accommodates and utilizes the three learning modalities, or pathways, through which people learn—visual, auditory and kinesthetic. Unlike some scripted and rigid reading programs, the Orton-Gillingham Approach is a system that allows for flexibility based on the individual learning capability of each student. All Montgomery students will benefit!
- Provided multiple teacher grants totaling \$4,890.37 to support activities in the classroom (e.g. PE equipment, art technology equipment).
- Funded visit by renowned recycling and "trash fashion" expert Nancy Judd.
- In support of our MES Ignite! initiative, \$21,922.97 was spent on the Innovation Lab 1.0, a classroom that was transformed into a flexible, aesthetically pleasing learning space modeled after the Georgia Department of Education's Center for Classroom Innovation. It features new furniture, technology equipment and learning tools that allow us to enhance students' 21st century skills and provide blended learning opportunities. Moreover, it supports learning opportunities geared towards having students investigate and respond to authentic and complex questions, problems and challenges.
- \$7,036.51 was spent on ongoing operations including insurance and marketing expenses.
